The Empire State Capital Area Chapter of the American Society for Public Administration

The Empire State Capital Area Chapter of the American Society of Public Administration (ASPA), the nation's most respected society representing all forums in the public service arena, was organized in 1942 as a discussion group of twenty-five persons to address the lack of professionalism and training in the newly expanded state government. The chapter (known until July 1989 as the Capital District Chapter) was officially chartered on December 5, 1945.

On July 1, 1989, the chapter changed its name to the Empire State Capital Area Chapter in order to distinguish it from other "capital area" chapters and to more accurately define the area it covers.

The chapter was instrumental in creating the Albany Graduate Program in Public Administration in September 1947. The school was originally co-sponsored by Syracuse University and New York University but is now part of the Rockefeller College of Public Affairs and Policy, University at Albany, SUNY.

During the 1980's, the society's main area of concentration was ethics in government. The chapter does no lobbying; instead, ESCAC-ASPA tries to improve advernment through the sponsorship of training, seminars, and workshops.

Most recently, the Chapter, in cooperation with the State Academy for Public Administration, has been instrumental in the development of Essentials of Public Administration in New York State, an award winning training program that has, for the last six years, provided a mechanism for leaders and emerging leaders in New York State government to learn about the mechanics of state government; to learn the processes that make policy into implemented program.

As the Chapter completes its 64th year, you are invited to reaffirm your commitment to the improvement of public administration in New York State by joining the American Society for Public Administration.

White is Associate Professor of Public and International Affairs at the Graduate School of Public and International Affairs in Pittsburgh, PA.

White has been a member of the American Society for Public Administration for more than 20 years. He served as program cochair for ASPA's 2004 conference in Portland, OR and has worked on ASPA's endowment board for several years. He was elected as a fellow to the National Academy of Public Administration in 2000.

White received his bachelor's degree in political science and philosophy from North Carolina Central University in 1972. He went on to earn a master's degree in administrative services from East Carolina University in 1978 before receiving his Ph.D. in political science from the University of North Carolina - Chapel Hill in 1985.

2007 ASPA AWARDS COMMITTEE

The difficult task of reviewing, ranking and selecting the recipients of the 2007 ESCAC-ASPA Awards resided with the members of the Awards Committee. Thanks to the members of the 2007 Awards Committee: Alice Roberson (Chair), John D. Bell, Mark A. Heller, Dr. Robert M. Purtell, and William Tyrrell for their work.

ALFRED E. SMITH AWARD

The Alfred E. Smith Award is presented in recognition of outstanding service and initiative by an individual which has exemplified superior management and administration within New York State and which has contributed significantly to the resolution of a major government problem, or to the development of a major governmental program, or which has effected major economies and/or efficiencies in the governmental process. The service rendered, *which may consist of a singular accomplishment*, should be far in excess of the normal expectation of the duties of the nominee's position and the level of the position within the organization.

THERESA E. SALO 2007 ALFRED E. SMITH AWARD RECIPIENT

A career civil servant who has held executive positions in three agencies over the last 20 years, Theresa E. Salo was cited for her significant efforts in developing New York State's Crimestat program. Crimestat is a performance management system that measures criminal justice performance, the outcomes of crime reduction efforts and the effectiveness of services provided by criminal justice agencies. It is modeled after New York City's highly successful Compstat system. Since Crimestat was initiated, DNA processing time was reduced from 177 days to 57 days, the processing of Crime Victims Board claims has been reduced from an average of 492 days to 119 days and inmate preparation has been dramatically improved. Three years ago, less than half of the inmates released completed intensive pre-release programming. Today, over 70 percent complete the program. "Terry Salo is the very model for public service," Commissioner O'Donnell said. "She is incredibly hard working, diligent, committed and tireless. She does everything she is asked to do, and much more, and manages to handle late-breaking, knuckle-biting projects efficiently and cheerfully. The citizens of New York State - and their new commissioner of DCJS – are very lucky to have her in Albany." Ms. Salo was nominated for the award by Chauncey G. Parker, former director of criminal justice.

CHARLES EVANS HUGHES AWARD

The Charles Evans Hughes Award is presented in recognition of outstanding service by an individual which has exemplified superior management and administration within New York State and which has contributed significantly to the resolution of major governmental problems, or to the development of major governmental programs, or which has effected major economies and/or efficiencies in the governmental process **over an extended period of time**. The service rendered should be far in excess of the normal expectations of the duties of the nominee's position and the level of the position within the organization.

FRANKLIN HECHT 2007 CHARLES EVANS HUGHES AWARD RECIPIENT

Franklin Hecht has worked for over 27 years for the New York State Office of General Services, where he presently holds the position of Director of Administration. He is credited with demonstrating that some agency program areas had grown over dependent on contract staff. The result – over 50 new State positions being added to the OGS budget for the following year which enabled the agency to provide a more economical approach to the work being performed. Additionally, in response to the statewide petroleum tank replacement program, Mr. Hecht organized and administrated a coordinated system to replace all underground fuel tanks on time and included a component that permitted agencies to share tanks, which reduced cost to the State. Mr. Hecht is credited with the establishment of an Equipment Maintenance Program (EMP), allowing agencies to convert numerous vendor contracts into one service agreement, saving the State 25% over individual vendor contracts. Saving results of this program have been calculated as being over \$1 million. In addition to his illustrious career, Mr. Hecht is also an active member of the Association of Government Accountants. Daniel Hogan, immediate past Commissioner of OGS, nominated Mr. Hecht.

FRANK C. MOORE AWARD

The Frank C. Moore Award is presented in recognition of outstanding service by an individual that has exemplified superior management and administration **within local government**, and which has contributed significantly to the resolution of a major governmental problem, to the development of a major governmental program, or that has affected major economies and/or efficiencies in the governmental process. The service rendered may be recent and singular or may encompass a series of accomplishments over a period of time. Such achievements should be far in excess of the normal expectations of the duties of the nominee's position and the level of the position within the organization.

JEFFREY DAMMEYER 2007 FRANK C. MOORE AWARD RECIPIENT

Jeffrey Dammeyer has forged new pathways for operations in the Town of Bethlehem by eliminating manual processes and implementing new technologies for twelve operating divisions to enable the town to "do more, with less." Mr. Dammeyer has created and maintained the Town's Web site in a format that is both user-friendly and reflects positively on the community. In 2007, Mr. Dammeyer and the staff launched an e-newsletter to subscribers, which has been lauded for its relevant content and its format. He is vigilant about security and protects system integrity against external threats by updating the hardware with the latest security software. He is a leader who can provide formal training for all users on new applications to continuously promote arowth of their skills. Mr. Dammeyer, as a key member of the Town's senior management staff, provides invaluable perspectives on operational and technology issues. Immediate past Town Supervisor Theresa Egan nominated Mr. Dammeyer.

The recipient of the inaugural ESCAC ASPA Scholarship, Vanessa D'Eredita, possesses a superb track record of academic excellence and public service. A graduate student in the MPA program at the University at Albany's Rockefeller College of Public Affairs and Policy, Ms. D'Eredita has an impressive 3.5 GPA and is a Fellow with the Center for Women in Government and Civil Society.

As a Fellow, Ms. D'Eredita works with the Bureau of Refugee and Immigrant Assistance (BRIA). Additionally, she has worked for the College of St. Rose's Community Service and Global Outreach Office, the Albany District Attorney's Community Intervention Initiative, and the Arbor Hill Community Center's After School Program.

Ms. D'Eredita graduated cum laude in 2005 from the College of St. Rose with a BA in history and political science, and is from Pleasant Valley, NY.
