OUTSTANDING ELECTED OFFICIALS OF THE YEAR 2010

The Outstanding Elected Official of the Year Award recognizes a current elected official whose career exhibits the highest standards of dedication, excellence and accomplishment. Nominees must represent the citizenry within Nebraska. A nomination should present evidence of the nominee's outstanding leadership qualities, high professional and ethical standards, admirable record of achievement, and strong commitment to public service and dedication to democratic ideals.

OUTSTANDING PUBLIC ADMISNITRATOR OF THE YEAR 2010

The Outstanding Public Administrator of the Year Award recognizes an individual within Nebraska who is currently working within the field of Public Administration. A nomination should demonstrate the nominee's noteworthy contributions to public service through their organization's goals and objectives. The nominee should demonstrate a tradition of excellence through outstanding achievements, a commitment of professionalism, exceptional leadership qualities, high ethical standards and a devotion to public service and democratic ideals.

To nominate an individual, the attached form must be completed and returned along with a description detailing support for the nomination. The ward category should be clearly marked. *The nominator is responsible for presenting the award to the recipient at the ASPA Award Luncheon which is scheduled for Thursday, April 29, 2010.* The ASPA award committees will let the nominator know when it has received the nomination and when a recipient has been chosen.
